**FOR STUDENTS ENROLLING IN 30 HOUR CLASSROOM AND/OR BEHIND
THE WHEEL PROGRAM**

Thank you for your interest in attending Tri-City Driving School. We are Adult & Teen certified by the Illinois Secretary of State for classroom driver education (30 hours) and behind the wheel instruction options (6/6 or 8/0).

The Driver Safety classroom sessions are taught in 2 hour lessons consisting of 15 classroom meetings. We offer classes right after school, evening classes, and weekend classes.

The Behind The Wheel driving lessons are also in 2 hour time blocks. We have very flexible driving hours to meet your needs. We have driving instruction appointments in **Granite City, Edwardsville, Bethalto, & East Alton** during the week and daytime hours on Sat. & Sunday. *We can help you finish your driving hours in 15 days!*

***Driver Safety Classroom- Enrollment Requirements:**

1. Must turn 15 years old on or before the last day of the classroom part of the program.
2. Proof of Academic Progress: (**1 of the following**) Please return after completion.
 - a. Show proof of passing 8 classes during the past 2 semesters of school (Blue Driver Ed Approval Form must be signed by school administrator).
 - b. Show proof of enrollment in an alternative or home school program. (Gold form).
 - c. A completed waiver form from your district school superintendent (Pink form).
 - d. Show proof of enrollment in GED class or completion certificate.
3. Fill out the parent/student section on the Registration form and return it to us.
4. Read, sign, and date the Rules sheet in this info/registration packet and return it to us.

The classroom consists of lecture over Rules of the Road and Drive Right textbooks. We also use a variety of media presentations and assignments to reinforce lessons. The total points for all assignments including quizzes and tests determine final grade. The grading scale is 90% to 100%= A, 80% to 89%= B, 70% to 79%= C, 60% to 69%= D, 59% and below= F.

***Behind The Wheel Only-Enrollment Requirements:**

1. Students need proof of passing the classroom (driver safety) from their school. (A copy of the report card or a transcript). ** BTW drivers do not need the colored consent forms!*
2. A copy of your drivers permit.

The Behind the Wheel grade is separate from the classroom grade. The BTW grade is determined by the student's ability to apply Rules of the Road, driving skills, car control, and execution of specific driving maneuvers. The student will receive an A,B,C,D, or F grade to be determined on student's final exam drive. The letter of completion to the State will not be sent until all required paperwork, academic progress, and fees are in proper order.

Program Costs:

1. Classroom with Behind the Wheel course is \$400.(Discounted to \$360 if paid at registration).

2. Payment plan: \$100 registration fee (deposit).
 \$150 by the *third* day of the classroom.
 \$150 by or on the *last* day of class.

1. Behind The Wheel only course is \$280. (Discounted to \$250 if paid at registration).
- or**
2. Payment plan: \$140 due at registration (deposit).
 \$140 due on the last drive.
- Total \$280

* Classroom Only course is \$200. (No prepayment discounts or payment plans available).

To Register:

1. Complete and return the Registration form.
2. Complete and return the Secretary of State Consent form (colored paper).
3. Complete and return the Rule's sheet.
4. Indicate which class you are enrolling in.
5. *Pay either discounted course payment price or deposit if choosing payment plan. We accept payment by check, money order, or cash if paid in person. Soon to take debit & credit cards!*
